

PROCESSING OF PERSONAL DATA NOTICE

Pursuant to art. 13 of Regulation (EU) 2016/679 - European Data Protection Regulation (hereinafter, the "**Regulation**"), we inform you that in order to provide you the products requested or planned for you, it is necessary to process some personal data related to you.

WHAT DATA WE COLLECT

These are data (such as, for example, name, surname, residence, telephone and electronic contact details, place and date of birth, nationality) that you provide to us; the provision of this data is generally necessary to execute the contract concerning the sale of our products.

WHY WE ASK YOU FOR DATA

Your data will be processed by our company in order to execute the contract concerning the sale of our products and carry out the related obligations. The provision of this data is generally necessary for the provision of the service and for its management and execution; in some cases, it is mandatory by law, regulation, European legislation. In the absence of such data, we would not be able to correctly provide you with the requested service.

HOW WE PROCESS YOUR DATA

To pursue the aforementioned purposes, your data will not be disclosed and will be processed with suitable methods and procedures, including IT and telematics, and may only be known by the personnel in charge of the structures of our company responsible for the supply of the products and services that you concern and by external parties to whom we entrust certain tasks of a technical or organizational nature, who operate as data processors on our behalf (goods delivery companies, such as couriers and freight forwarders, postal transmission service companies, enveloping, transport and sorting of communications to customers, banks, IT and telematics or archiving service companies).

In relation to the aforementioned processing, your data will be kept in full compliance with the security measures provided by the privacy legislation and will be kept for the times established by the legislation on the conservation of documents for administrative, accounting, fiscal and contractual purposes (generally, for 10 years).

WHAT ARE YOUR RIGHTS

The privacy legislation (articles 15-22 of the Regulation) guarantees you the right to access the data concerning you at any time, as well as to obtain their rectification and/or integration, if inaccurate or incomplete, their cancellation or portability of the data provided by you, where processed automatically for the contractual services requested by you, within the limits of the provisions of the Regulation (art. 20). Privacy legislation also gives you the right to obtain the limitation of the processing of personal data, if the conditions are met, and the opposition to their processing for reasons related to your situation.
